## **FORM 6: Change of Name**

## **GUIDE TO COMPLETING THIS FORM**

The name of a registered dog can be changed only once, by the addition of a registered affix to the original name. For such name change, the limit of 24 letters no longer applies.

Before the name of a registered dog can be changed by a new owner, the change of ownership must have been completed.

The change of name of a registered dog may be effected, subject to the condition that if the dog wins a prize or certificate of merit in competition, the old name, as well as the new name must be given when the dog is entered for exhibition or at a field trial until the new name has been published in the Official Journal of the East Africa Kennel Club.

Every registration at the East Africa Kennel Club implies submission by the person registering to the East Africa Kennel Club Rules in all canine matters.
