FORM 1 – APPLICATION FOR REGISTRATION OF ONE LITTER

To be completed in accordance with EAKC regulations

PLEASE READ THE FOLLOWING NOTES CAREFULLY BEFORE COMPLETING THIS FORM

- 1. This form is for use by the BREEDER (owner of the dam at the time of whelping) to register a litter.
- 2. Full details of the litter must be provided herein.
- 3. All puppies from the litter for which the BREEDER requires registration must be included in this application. Separate or later applications for registration will not be accepted.
- Applications in the names of JOINT OWNERS must bear the signature of ALL such JOINT OWNERS.
- 5. In the case of a SCHEDULED BREED this application must be accompanied by the requisite VETERINARIAN CERTIFICATE on the appropriate EAKC form.
- Throughout this form the following abbreviations and alternatives will be found or are acceptable:
 D = Dog = Male
 B = Bitch = Female
 Sire = Father
 Dam = Mother
- 7. Where boxes have been provided for names etc only one letter, space or punctuation mark shall be placed in each box. The given number of boxes (24) may not be exceeded.
- 8. Any person applying for a registration is deemed to be bound by the EAKC Rules and Regulations in all canine matters.
- 9. Only Class 1 of Registered dogs are eligible for issue of Export Pedigrees.
- 10. A dog's name is selecte by the person first registering the dog
- 11. A name must consist of more than one word, but no name including Affix shall exceed 24 letters, each space, hyphen, full-stop or apostrophe to count as one letter.

- 12. The following are not acceptable for inclusion in names:
 - Names of notable persons
 - Numbers in figures, or in words if indicating a sequence
 - A single letter word to begin a name
 - The registree's surname
 - Canine terms, e.g. dog, bitch, champion, Crufts, kennel, breed names, or breed abbreviations such as Doby
 - Proper or geographical names where these are part of the breed name e.g. German, or Germany for GSD.
 - Words from a dog's pedigree which may be affixes held by another person.
- 13. When naming a litter, the same word may not be used in more than two puppies unless application has been granted to use this word as an Affix, or it is used in conjuction with an already registered Affix.
- 14. An alternative name must be submitted in addition to the one desired; except in the case of dogs registered only for obedience, Agility or Working trials.
- 15. A name once registered cannot be registered in the same breed for 15 years after the 1st January following the last registration
- 16. The council reserves the right to refuse to register any name which it regards as inappropriate.

NB: For each Litter Registration a Litter Fee is charged at the applied rate equal to 1 Puppy.

NOTES TO BREEDERS

AFFIXES

An Affix is a single word of no more than 12 letters which you wish to use as part of each dog's name in registering all litters which you breed.

Unless prohibited by endorsement, it may also be added to the name of a dog previously registered by someone else, at the time when that dog is officially transferred to your ownership.

Only voting members of the EAKC may apply to council for the grant of an Affix.

Once granted, an Affix must be maintained by the payment of an annual fee.

Application for grant of an Affix must be made on a separate form which sets out the further requirements in detail.

PEDIGREES

It is your responsibility as a breeder to issue a Breeder's pedigree of at least four generations to the buyer of each registered puppy in this litter.

A four-generation blank pedigree form for each puppy registered in this litter will be sent to you by the EAKC together with the Certificates of Registration.

The blank pedigree forms are for completion by the breeder, and are not official pedigrees or valid for export purposes.

The breeder's pedigrees should not be returned to the EAKC.

Separate application, accompanied by the relevant fee, must be made for Official Pedigrees, or Export Pedigrees when required.

TRANSFERS

The puppies you register in this litter will be registered in your name as the owner.

The puppies which you sell or give to other people must be officially transferred into their ownership after the date of the physical transfer.

The EAKC will send you an Application for Transfer of Ownership for each puppy registered in this litter.

The EAKC asks that you, obtain the signature of the new owner on the transfer application, and return the completed transfer applications to the EAKC yourself.
