4. If the signature of the **PREVIOUS REGISTERED OWNER** cannot be obtained for any reason, application can be made on this form supported by a letter of explanation. In these circumstances **SUPPLEMENTARY DECLARATION** by the **NEW OWNER** must be completed (See reverse)
5. Throughout this form the following abbreviations will be found or are accepted:
D = Dog = Male, B = Bitch = Female, Sire = Father, Dam = Mother.
6. No transfer can be affected until this form has been returned to the EAKC Office
7. Any person making a registration is deemed to be bound by the EAKC Rules & Regulations in all canine matters.
8. Only Class 1 Registered dogs are eligible for issue of an Export Pedigree.
